Dear Sir/Madam,

In compliance with the provisions of Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and further to our earlier intimation dated 15th May 2023, we hereby notify that pursuant to the Share Purchase Agreement dated 28th September, 2023 executed between the Company, Saba Investment Limited, UAE ("Saba") and Shibham Group Holding Limited, UAE, the Company has divested its 51% stake held in Saba for consideration of USD 6 million.

Accordingly, Saba and its subsidiaries viz Cipla Middle East Pharmaceuticals FZ LLC, UAE and Cipla Medica Pharmaceutical and Chemical Industries Limited, Yemen, have now ceased to be subsidiaries of the Company w.e.f. 29th September, 2023.
